## THE CORPORATION OF THE TOWNSHIP OF BALDWIN BY-LAW NO. 2025-008



## BEING A BY-LAW FOR THE ADOPTION OF TAX RATES AND TO FURTHER PROVIDE FOR PENALTY AND INTEREST IN DEFAULT OF PAYMENT THEREOF FOR 2025

**WHEREAS** Section 312 (2) of the Municipal Act, S.O. 2001, Chapter M.25. .S.O. 2001 as amended by Bills 106, 149, 160, 164 and 16 provides that the Council of a local municipality shall, after the adoption of estimates for the year, pass a by-law to levy a separate tax rate on the assessment in each property class;

**AND WHEREAS** Sections 362 of said Act require tax rates to be established in the same proportion to tax ratios; and

**AND WHEREAS** the 2025 levy for all purposes has been adopted by the Council of the Township of Baldwin;

AND WHEREAS certain education rates are provided in various regulations;

**NOW THEREFORE** the Council of the Corporation of the Township of Baldwin enacts as follows:

1. **THAT** the tax rates for 2025 for municipal and education purposes be hereby set as follows:

- 2. **THAT** all taxes shall become due and payable in 2 installments as follows: 50% of the final levy becomes due on the 21<sup>st</sup> day of June, 2025. 50% of the final levy becomes due on the 21<sup>st</sup> day of August, 2025.
- 3. Nonpayment of the amount as noted on the dates stated in accordance with this by-law constitutes default. On all taxes of the levy which are in default after the noted due dates, shall be added a penalty of 1.25% per month, until December 31, 2025.
- 4. On all taxes unpaid as of December 31, 2025, interest shall be added at the rate of 1.25% per month for each month or fraction thereof in which the arrears continue.
